At the same time as lodging this Supplemental Claim Form, please also deliver to the Adjudicator: (a) certified true copies of all Additional Evidence of Ownership (as defined below) for your Shares as of 18 May 2016 and/or 13 September 2022 (as applicable); (b) if you are a legal entity other than an individual (“**Body Corporate**”), a certified true copy of the resolutions of the board (or the equivalent body) approving the execution of this Supplemental Claim Form; and (c) if you are signing as attorney, personal representative or successor, certified true copies of all documents verifying your signing authority.

“**Additional Evidence of Ownership**” means additional evidence of ownership that you wish to provide addressing the matters stated in the Reasons for Rejection showing that you were the beneficial owner(s) of your Shares as of 18 May 2016 and/or 13 September 2022 (as applicable).

“Reasons for Rejection” means the reasons for rejection set out in the notice despatched by the Adjudicator to you on the last day of the Verification Period notifying your Claim is unsuccessful.

**The Adjudicator reserves the discretion to request for additional evidence or documents for the purpose of verifying the validity of a Claim. In addition, the Adjudicator may, in suitable cases and in its sole opinion, require such evidence to be notarized or otherwise supported if provided from or involving an overseas jurisdiction.**

7. When preparing certified true copies, the certifier must be a member of a legal, accounting or company secretarial professional regulatory body (regardless of whether such certifier is practicing or not) acceptable to the Adjudicator and the certifier shall include his/her signature, full name, date of certification (must be less than three months’ old), details of the certifier’s position or the capacity in which he/she is signing, contact details, the name of the professional regulatory body of the certifier and include the certifier’s registration number issued by the regulating body. 3. The Adjudicator shall provide an acknowledgement of receipt of this Supplemental Claim Form to you within seven (7) days upon receipt of this Supplemental Claim Form.

To determine the validity of a Claim, if the Adjudicator deems necessary, the Adjudicator will, on a *case-by-case basis*, liaise with the Company and major Hong Kong brokers and banks for relevant shareholding and transaction records to the extent practicable. In this connection, by submitting this Supplemental Claim Form, you agree to the personal information collection statement (including the use and/or transfer of personal data to contact your certifier, bank managers, solicitors, accountants, licensed securities dealers or registered institutions in securities) set out in this Supplemental Claim Form. ## PERSONAL DATA

### Personal Information Collection Statement

This personal information collection statement informs you of the policies and practices of Sino Wealth, Clear Prosper and the Adjudicator in relation to personal data and the Personal Data (Privacy) Ordinance (Chapter 486 of the Laws of Hong Kong) (the “**Ordinance**”).

#### 1. Reasons for the collection of your personal data

#### 2. Purposes

The personal data which you provide in this Supplemental Claim Form may be used, held and/or stored (by whatever means) for the following purposes:

- establishing your entitlements under the Payment Plan;
- conducting signature verifications and any other verification of the information you provide;
- distributing notices and communications to you from Sino Wealth, Clear Prosper, the Adjudicator and/or their respective agents, officers and advisers;
- compiling statistical information relating to the Review Applicants;
- making disclosures as required by laws, rules or regulations (whether statutory or otherwise), including to the Stock Exchange, the SFC and applicable regulatory or governmental bodies, and otherwise to comply with any legal obligation to which any of Sino Wealth, Clear Prosper and/or the Adjudicator is subject;

- any other persons or institutions with which you have or propose to have dealings, such as bank managers, solicitors, accountants, licensed securities dealers or registered institutions in securities, or otherwise ask us to communicate with; and
- any other persons or institutions whom Sino Wealth, Clear Prosper and/or the Adjudicator considers to be necessary or desirable in connection with any of the above purposes.

#### 4. Access and correction of personal data

The Ordinance provides you with rights to ascertain whether Sino Wealth, Clear Prosper and/or the Adjudicator hold your personal data, to obtain a copy of that data and to correct any data that is incorrect. In accordance with the Ordinance, Sino Wealth, Clear Prosper and/or the Adjudicator have the right to charge a reasonable fee for the processing of any data access requests.
